FOR SPEAKERS:

About oral presentation

The topics of oral presentations should coincide with the names of an article.

The speakers will be informed by **24th August 2018**. All speakers must have their articles submitted and accepted.

The articles must be submitted in electronic form by **20th August 2018**.

Oral presentations are followed by Power Point.

The speakers must submit their presentations in Power Point to Christine Rozhko rozhkokris@yandex.ru by **3th September, 2018**.

ARTICLES

The proceedings of the II National Congress “Rehabilitation – XXI century: Traditions and Innovations” will be in a book that you can find on the website of the Congress later.

The articles must be submitted on the website of the Congress by **20th August 2018**.

We kindly ask you to submit works beforehand. We will not accept them after deadline.

General requirements for articles:

- Articles must be submitted via the Congress website http://www.reabincongress.ru/english_conf/ only. Deadline for article submissions is 20th August 2018.
- The volume of articles is up to 5 pages of A4 format (including references), type is Times New Roman 14 with 1,5 interval.
- According to the standards of RSCI, short papers must have the title, family name, first name(-s) and patronymic name (for those who have it), affiliation details: the name of institution, city, country for each author (if all authors work in one institution, it is possible not to indicate the place of affiliation for every author separately), key words and abstract.
- The text should be indented and regulated thoroughly.
- Articles must be submitted with the following sections:
 - Background and aims
 - Methods
 - Results
 - Conclusions
- The list of references must be placed after the section ‘Conclusions’. In their papers, authors must mention all references included in the list of references.
- The Scientific Committee has the right to reject an article without assigning any reasons. All articles which do not meet the requirements will be rejected.

Please, check the requirements for articles on the website. They can be changed lately. There will be original paper and Russian translation in the proceedings of the Congress. You can send your Russian variant, if it is possible. All articles will be translated by Christine Rozhko.
